### INTRODUCTION

UNESCO Global Geoparks in Norway is in the process of creating our national Norwegian Global Geoparks Network, inside the framework proposed by GGN. The foundation meeting will be on the 8<sup>th</sup> of December 2025 and the proposal will be sent to GGN Executive Board for their endorsement. The members in this network will be the five Norwegian Geoparks.

The structure of the existing committee will probably function in the future as an advisory- and resources body. We need to explore further the role of this committee; the main issue is regarding the situation with the workstream for Norwegian applications and reports regarding UNESCO Global Geoparks: the responsibility for sending the official documents to UNESCO secretariat in Paris. This was done many years ago, as our Geological Survey of Norway was given the responsible for evaluation of the geological heritage with regard to the international scientific value and the Norwegian UNESCO Commission stated that they lacked capacity and resources to take this responsibility. We hope to discuss this issue with the existing Norwegian UNESCO commission, which we will meet on the 9<sup>th</sup> of December 2025.
