They are public documents, collected and assessed by the Global Geoparks Network.

The Annual Reports are used for the objective assessment of the operation and activities of the individual Geoparks and their Geopark Networks.

Geopark Reporting is based on Templates to achieve homogeneous presentation of the Geopark data.

They are also used as additional source of information for the Geopark Revalidation exercise.

A Geopark Annual Report is a yearly publication that all UNESCO Global Geoparks are required to share with the Global Geoparks Networks, its Regional / National Networks and GGN Members, outlining their operational and business performance as well as financial status.

It reviews the past year's activities, includes future perspectives, and provides comprehensive financial and operational data.
